5.1 Young African Union

Mujurv Mugisho Jean Claude

New Club, second year running. Is planning a huge cultural event including musicians, drama, fashion.

Would like to include performers from all backgrounds to celebrate diversity. Club has 8 executives on their board.

Asking for financial backing: Need prizes for raffle/draw for people to attend. Low admission - \$8

Prizes to include a TV and gift cards. They will be renting out Iona College in order to bring cultural food. Cost: \$700 dollars for food.

Wants to reach out to students who have travelled from abroad and are new to Canada.

Dejong: What's the total cost of the event?

Mujurv:\$751

El-Dika: This is a ratified club?

El-Dika: How exactly will the funds be used?

Ogunbande: Why did the costs change with your guest speakers?

Reeva: It was a very high profile speaker in attendance and there were 2 additional guest speakers.

El-Dika: What happened to the minutes?

5.3 Nigerian Student's Association

Eva

150 people have previously attended event. Expecting 200 people.

Volunteers complained they had to pay their own admission to make the show a success. The event will have a Broadway show during the event. Their show last year did receive funding.

Budget includes:

Catering, Rental equipment, photography, performers, printing of flyers and tickets, videography, costumes, décor, misc.

Total budget \$3,825

Event did not break even with their event until after their event had already taken place.

Sponsors include: Pizza Plus, JP African Store

Selling tickets for \$20 and expecting 200?

Eva: 200 people – 50 not paying because they are volunteers.

Ogunbande: Estimate 120 people at \$20, you are asking for

Tara

Overall the Pub brought in approx.. \$70,000 from the Avicii concert

\$1,170 Profit

The pub has lost \$1,142,000.00

Statements are going on a non-concerned basis.

The organization is in compliance.

Previous executive made the decision, not to re-audit the forms with the changes made and feels confident in that decision saving the UWSA money.

4.5 million dollar student fee revenue. Increase from last year.

Funds spent went towards a new outdoor seating space, and renovations on the new restaurant.

Operating did make profit.

Lance, CAW centre are in loss.

Lance is in deficit of \$30,000. Owing from operations.

1.2 million in liabilities. Mainly from being the banker for clubs and society money that you are holding from them.

The audit included testing including payroll files.

Minutes not regularly take and they need to be provided.

There are clubs and societies currently in overdraft

position. They need to be closely monitored.

VISA and expense reports are carefully scrutinized.

El-Dika: Go in detail about the overdraft of the clubs and societies.

They overspent near the end of the year and now are owing monies on their account.

Bolbol: How did the Pub spend money?

Tara: It included severance, manager's salary for the special event he was hired for.

BIRT the board approve the audited financial statements for the year ended April 30, 2013 dated today's date, September 26, 2013.

6.2 The Lance Deficit

Crawford: Would like to honour the agreement with the Lance. Previous decisions made by April broke the first agreement. Would like to uphold that agreement.

Jon: Lost the second half of their space since the bookstore took over half of the office space. That agreement was broken in 2010 and 2011.

Crawford: UWSA broke the agreement and would like to rectify the situation. Dr. Wildeman has agreed to pay half of the Lance's deficit. 202 is the first time it operated in a deficit since the UWSA took over it. The Lance has offered in kind advertising if the deficit is covered.

3 different options for the board to consider:

One full payment

2 year payment period

3 year payment period.

There is a surplus in advertising and it could allocated towards the deficit. Or perhaps take it from the Oops fund.

Previous amounts spent on The Lance include \$5,825 for ads in 2011. No time constraints for the advertisement amounts.

The motion would have to be amended to the amounts that the board sees fit.

Jon: The point of this is remedying the relationship. The amount of negative attention received by The Lance, the UWSA and the university as a whole can't happen.

Lance did fall into deficit. Reason being their national advertising company went bankrupt. 80% amount owed. (\$10,000). Auditing only went to April so it conflicts with the report given earlier. The deficit amount has decreased.

In 2 months \$25,000 in advertisement has been made. That's 1/3 of projected revenue for a full year for The Lance. Lance receives the lowest student levy in the country. CJAMS levy is double The Lance has 9 staff and CJAM has 2 and half staff and their levy is double.

Request to accept the 2 year payment plan. That would be 2 years of not paying for advertisements an in kind trade. You wouldn't have to purchase advertising.

Dejong: In favour of the motion. Would like to see an amendment that the advertising be decided by the Board so that they have discretion on how the advertising allotment is used. It could be allotted toward club events.

Crawford: Does this mean that the UWSA needs to approach the board to use advertisements?

Dejong: The board can allocate portions of the advertising budget. The clubs coordinator could then allot a portion for advertising for their purposes, etc.

El-Dika: Do we have a letter of intent from Wildeman?

Crawford: Has it in email form.

Hussein: Would the advertisement be in print or online?

Jon: Everything is open.

El-Dika: Why are you pushing the 2 year plan?

Crawford: If the Lance is doing better next year. It's just safer bet. Reassess the deficit next year.

Jon: You could pay it all back in the first year, but if you have the option to space things out and there is no penalty, it makes more sense.

El-Dika: How would you see things changing if it were 4 years?

Jon: 2014-2015 could start affecting them financially. Already cut the amount of issues being printed and the amount of pages on certain issues.

Crawford: The Lance would like to move towards independence and this could impede it. Create too long of dependence on the UWSA.

Jon: Hinders the ability to move towards creating good content for students.

Hussein: not necessary for it to state in the motion that the UWSA broke the agreement with The Lance.

Chair: Requests that The Lance leave the room for the board to deliberate.

Dejong: In favour, only if the university also pays the other half. If they do not pay, then the UWSA does not have to pay the other half. It will only cost \$2000 more than what they would spend on advertising. A three year period may be easier, that's \$800 less than you will be spending on advertising this year, so it is actually creating a savings.

Akbar: Concerned that if The Lance is better in financial shape in the next year or two the board should be able to decide not to pay off the deficit.

Hussein: I'm not sure it would the smartest thing to include in the motion that they broke an agreement with The Lance.

Crawford: If the deficit was reduced. The board wouldn't have to pay that amount. If there is no longer a deficit, the board won't have to pay.

Does not see anything wrong with admitting the UWSA messed up. Needs to be accountable to members.

Dejong: Issue year after year could mess with the university agreement. The university is willing to pay for

half of the deficit and if we do not pay the other half, it could be breaking a second agreement.

S.Akbar: Agree with Hussein. It needs to be done separately, if they need to do it. Makes the board look pressured to approve the motion. It pressure the board to vote a certain way. We should be transparent if we have broken an agreement but it shouldn't be in the motion.

El-Dika: Does not make it look guilty. No personal investment in The Lance. Guilt is not an issue, if it did go to legal litigation, it is already proven.

Crawford: Wildeman did not have concerns with the 3 options and can have it documented.

Akbar: The UWSA did not interfere with the editorial content of the Lance. Believes it's debatable. There's two sides to it. Would not like to include those whereas clauses. Just do a good thing for The Lance without the clauses.

Shahid: How did the UWSA break an agreement?

Crawford: Board ordered them to cease operations.

Shahid: There is no number for the amount of space, does not see how that agreement was broken. There is still space available to the Lance.

Hussein: UWSA didn't break the agreement because they have the Lance oversight Board. They have a board with the power to do these things. Last year the UWSA board became The Lance Oversight Board. They used that authority to do these actions.

It's hard to take back that statement. The board does not have the knowledge or the ability to decide if they did something wrong. Leave that section out. It does not change the goal or the intentions of what's going on.

Dejong: Against the amendment, would like to keep the first clause.

Dejong: It explains why we gave the money. What specifically makes this bad?

Shahid: The order to cease printing operations could be viewed as a good thing instead of laying off everyone. They needed to figure out how to handle the deficit. The media portrayed the UWSA negatively even though this was wrong. The Lance printing created negative publicity for the UWSA. Does not want a free reason for The Lance to use it against them.

Kyra: To keep the story out of media, putting a motion forward with just money and no explanation would create an issue.

Hussein: This would not do that. The board wants to keep The Lance in good financially standing so we're going to give them money and amend the bad relationship.

Dejong: Against the amendment of eliminating all the whereas clauses. The point of a whereas clause is to explain the motion. So that when people look at the minutes, they have an understanding of why those decisions were made.

Shahid: In favour. Oversight board could not communicate with Erik Pigeon with financial issues because their meetings conflicted with UWSA meetings. Once the UWSA took over in the new year, that's when the UWSA discovered they were in deficit.

El-Dika: Against the amendment. Should only strike the third clause . Number of factors that put them in a poor financial situation. Provide transparency and create accountability to show members.

Akbar: In Favour, to just remove all the whereas clauses. All of the discussion will be recorded in the minutes. Agrees that the last two whereas clauses are not needed. Let's just get rid of the all the whereas clauses. Everything that was said will be recorded.

Hussein: For the amendment. Wants to be transparent. Does not want anyone to be liable for decisions and amendments. Is for the amendment. Is actually against the amendment. If they include everything then as long as they sign agreement that they can never sue us for anything in the future. That way they are not responsible for it in the

future and not held liable.

Ogunbande: Are we scared that we will be held responsible for the words written here? As far as I'm concerned there are minutes that are recorded. We should just leave everything in the minutes, does not believe they will be sued. Against the amendment, would rather keep the clauses.

S.Akbar: For the amendment. No authority to state those things as fact since nobody present was there last year. The board need to keep the legal and financial statements in order. When you approve something you're saying yes this is what happened. We don't have the authority whether to say it's correct or not.

El-Dika: The first two whereas clauses are fact. We didn't have to be there. Third and fourth can be changed because the financial problems were coming from various reasons.

Short term problem in terms of keeping them on. Is hoping that the Board sees the value.

He was working on bare bones \$6000 into the summer. Will be looking at other positions.

Able to extend about his contract about 6 weeks. Corporate ad was able to pay for that.

Budgeting \$32,000 more in bank. Staff have made more than \$10,000 in concessions. Fundraising hard to get power increase. Working to advertise and put less pressure on the student body.

Will be approaching other organizations for funding.

Campus has benefited from having a news department

Ogunbande: How long do you expect to keep the news director.

Smith: Would like to keep him permanently. Someone with his experience will be very hard to replace. Will be working very hard to obtain funding. Would like to reconsider the student levy.

El-Dika: How long will this funding get him?

Smith: 6 weeks

El-Dika: Do you believe you will get enough funding until the end of the summer?

Smith: Yes. \$49,000 expense approaching. Other sources on campus and the community. Has never previously accepted Corporate funding but did with accepting corporate ad.

John: Appreciates the multiple sources of news in campus.

Bolbol: Where will the funding come from?

Shahid: Special events

Curtis - Cubs Coordinator

Oversees all events on campus. Helps work out details for events. Looking to upgrade software for clubs to make bookings. Clubs need to permission on campus to make sure they are ratified. (Went over procedure for current on campus event forms)

Problem with current system. 250 events last year. Would like to go to a new system, it was previously free management system.

Currently set up so groups see bookings. Allows clubs to see each other's events. It is embedded in the UWSA events calendar. Much less working than manual entry that was previously used.

Needed this support for some time in terms administration. Supposed to work 20 hours a day. Works closer to 40-50 because of processing paperwork.

This cost will be about \$1,100. October 1st there will be a free trial run to try out the software.

If we continue to underfund clubs, there will be a breakdown. There was once 3 coordinators in one year because the workload is intense. Student groups create a lot events for student life as compared to the UWSA.

Hussein: Long overdue. Experienced the process and going from office to office for 5 days with paperwork. There is no centralized system.

Crawford: How many hours a week would you say you work?

Chris: Tries to limit it to 40 a week.
