5.1 UWSA Partnership with Project Syria: Hussein Zarif

- Project Syria is a nonprofit student movement which aims to resettle and integrate Syrian refugees in Windsor.
- Help resettle 250 refugees in Windsor in the next 2 years.
- Awareness Events: Banner Events, Stopping the stigma, bridge the gaps and promote fair society.
- **Benefit Dinner**: Ask UWSA to promote and endorse the benefit dinner.
- Asking \$10000 for the refugee crisis.
- Invite UWSA to sponsor two tables in the dinner.
- The money will be used to help sponsor refugees and host info sessions that encourage people to sponsor refugees.

5.2 WUSC Program: Lodai

- WUSC (World University service of Canada): Leading government organization in terms of development.
- Involved in sponsorship of refugee students.
- Residence, food and fee covered by administration.
- Raising funds for Burkina Faso and sponsoring refugee students.
- Limited funds.
- Trying to find a way to raise amount of money not covered.
- Trying to ensure that 100% of it is waived.
- With a contribution of \$56500 from UWSA, they can a deficit of \$31500.
- Can negotiate the \$31500 with the administration to cover that amount, i.e. books, residence, tuition.
