**BIRT** the board approve the following referendum question regarding the LSRC:

"Be it resolved that an annual capital fee of \$125.00 per student (\$62.50 per term for a maximum of two terms per academic year) be levied on all members of the University of Windsor Student Alliance (UWSA) to support the construction of a new Lancers Sport and Recreation Centre (LSRC).

Be it further resolved that this fee shall be assessed commencing Fall 2019 or in the academic year that the building becomes operational, whichever comes later;

Be it further resolved that the fee shall increase by an annual increment of 5% per year for the first seven (7) years only;

Be it further resolved that in 2029, when the existing Sports & Recreation capital fee expires, the LSRC capital fee shall increase by the amount of that fee at that time;

Be it further resolved that the term of this fee shall be 30 years;

Be it further resolved that all fees generated shall be used exclusively to support the LSRC capital project."

**BIFRT** the LSRC referendum campaign and voting dates remain pending until a submission of requested dates by the LSRC Steering Committee is received and approval by the UWSA Board of Directors

**BIFRT** there be a stipulation that the campaign and voting days be held outside of the UWSA General Elections campaign and voting period

# 6.0 Reports

#### 6.1 Executive

#### **Student Services:**

- One of coordinators were dismissed, working with team leaders to find another
- Frost week coming together, coordinator will start January 6<sup>th</sup>
- It was brought up that the marketing for the events was not effective, social media is lacking
- Also suggested to have more "Paws Therapy" days

#### Finance:

- Finalizing list of pre-approved locations for clubs to have events and negotiating discounts for them
- WFCU never got back regarding financial literacy workshops, therefore will be setting up different financial literacy workshop in Ambassador Auditorium

#### Student Advocacy:

- CFS National General Meeting, good motions brought up
- Provincial meeting from January 19-22 in Toronto, looking for active attendance from board
- Food bank nearing completion
- Giving Tuesday funds/donations going to food bank

#### President:

- UBike winterized, city of Windsor interested in bike share program
- Flew to Montreal and sat with student health and dental insurance broker, talked about mental health coverage being a possibility
- Consulted with governance specialist for UWSA issues and concrete legislation, considering opening senior adviser position to uphold institutional memory
- Launching anti-racism taskforce in Windsor-Essex in winter semester. Want to bring stakeholders around the table to consider tangible progress
- Would like to involve art students to engage with on campus, art exhibition (Expression Against Oppression)
- Suggestion was to have campaigns 6 weeks from beginning of first-year, include education on UWSA
- Mental health is priority, student counseling expanded and nursing practitioner coming to campus, want to work with peer support centre coordinator to bring about another mental health campaign

#### 6.2 Committee

Student services: working on representing board members in respective buildings, bringing in suicide prevention speaker, gaming day in CAW Commons, pancakes with board members in each building

Finance committee: gave out a lot of sponsorships (funding, galas) -> underspending thus far

Student advocacy: talked about social action classes (childcare, anti-racism). In January, the board will have anti-oppression workshops for by-elects, attempt to get outlet testers to have mini-campaign to get posters near defunct outlets, board members will also be tabling to promote UWSA

GPC: met and brought forth pending recommendations, talked about by-law issues

University affairs: non-in-camera motion brought forth at Board of Governors was the passing motion of investment (with federal grant) in state-of-the-art science research innovation facility behind Essex Hall

Universities adapting to new tuition framework (OSG), students may choose not to disclose mental health issues to professor

#### 6.3 Senate

Student caucus meeting cancelled, general senate meeting for APC had motion for advanced statistics courses being swapped out so different course can be chosen for degree requirement.

University will be refurbishing degree audit, in which the new one will be implemented in 2018
