6.1 UWSA Action re: Bookstore

Mohammed Almoayad - Approval

"BIRT the UWSA do everything in its power to stop the bookstore from moving into the pub space"

Mohammed: One of the largest issues we will have to deal with as councilors this year. The decision to move the bookstore into the PUB was made with no real input into the move, was made by a few executive. This has such a large impact on the students on campus and we can make this change without approaching students. Doesn't want to focus on anything that has happened in the past, wants to focus on what can be done now. The reason this is coming up now is because we thought we didn't have a choice on what was happening board though that the bookstore had to go into the basement, now the construction is not happening until later so we have time to get student opinion. This motion doesn't say what goes into this space, it only says that we want to discuss what will happen with this space. This decision will effect even more students then are currently present on campus, and if they lok back and see there was no student imput then they will be angry that we as council did not represent students. We need to find out now what students want and not let this deal go forward without student input.

Sean: (Against) Was not aware that we have the ability to change the contract are we not legally bound by the contract. We don't have a means to talk to all of the students on campus we only have the social media. We do have the means to contact us and give us there opinion. It is not feasible to conduct democracy going out to each person. I would like to know how many students desent against this issue, I have only seen the few social media goups and only about 20 people desenting.

Mohammad: (against) I bit confused by the statements made that students aren't active on facebook that doesn't mean that students aren't angry we should go out and see if they like the idea. People do not critisise the UWSA to our faces we shouldn't say that we can't go out and get there idea, we could run a referendum, we are a common good they could run a referendum and take away all our fees. Students vote down everything we want because we had disenfranchised then, students are at the top of the hiarchy and we need to remember that. The only way we can get student feedback is through pools or referendums, we shouldn't be afraid of them, the Canadian government would be tottaly different if we had polls and refuerendums.

Mohammed: (for) It was made clear that we could back out of the deal, the university own the student centre and they can do whatever they want with it, the university would only give students soft consequences of we wanted to back out, they did not want to force the deal on students. People are saying that now it is to late they haven't started construction it will now be delayed this is not to late to take action. If we go to students and say the way we made this decision was wonge it will not be difficult to take there opinion and go to administration and loby them and say that this is not what students want. It is not unreasonable to go to the administration and lobby them and say the UWSA doesn't want this. They admin may be really annoyed they may not want to work with students in the future but we represent students not the admin we shouldn't care about how the admin feel, we should worry about how students feel. We may not be able to get consensus from 12,000 students but we can get enough consensus to say we represent then. For big things like this you can say that we don't need any input from students. We shouldn't say that it is too difficult a task to get students opinion. We need to give them adequate opportunity to voice there opinion. Even if exsecutive board and council only make decision this contract is still not legitimate because council didn't get together and say what should go into this space. Most councilors don't know what is in this contract and what the lost opertunity cost are. We shouldn't have exseucutive make a unilateral decision

Trevor (against): Do not see the croud of protesters do want to change the contract. Future deals with the administration will become more difficulty and as much as we don't want to pander to them we shouldn't go shooting future exsecutive or councils in the foot because they won't want to work with the UWSA. There will be risks to long term advocacy to the UWSA. Will make it more difficult for us to do anything in the future. \\
