8.10 Whereas on November 3rd the Steering Committee of the Ontario Undergraduate Student Alliance(OUSA) voted to increase the OUSA fee from 2.85 to 2.87

Whereas the UWSA council has not set the OUSA fee for this year

Whereas the VPUA made it clear to OUSA that the UWSA would have to vote on this fee increase before it's approval, and it was still increased, therefore;

BIRT the UWSA task the VPUA with giving OUSA 90 day's notice on a Council vote on the fee increase BIFRT this vote be treated as a vote on continued membership.

BIFRT the VPUA research student opinion through a Google poll on OUSA recommendations on the tuition fee framework during the 90 days, and present it to the UWSA council before the vote on OUSA BIFRT the motion and dates for this vote be set at the next council meeting.

Akbar: This is to give OUSA notice of the 90 days needed that we will be voting on this matter. Within the 90 days there will be an effort to find out whether students support the partnership with OUSA. According to previous motion it is the UWSA council's responsibility regarding OUSA fee increases. Do students agree with the OUSA mandates? Should this be a council vote or a referendum? Should the fee increase? Is OUSA's efforts for lobbying sufficient for the UWSA? Council vote or referendum are the two options to decide on how to proceed.

Zghal: Can we decide the dates at the next meeting?

Akbar: Yes

Almoayad: What other fees can go up by inflation?

Orr: The CFS fees go up by inflation.

SAL - President of OUSA: Inflationary increases will allow them to provide the same levels of services. The power to pass inflation is within their right. Anything above that must be approved. OUSA presented this issue because they would bound to because of their bi-laws.

The fee would cost an overall \$250 total to the UWSA and are willing to be flexible with that payments. There is representation from students at large and want to be able to address and advocate the needs of the students.

Chris: Has previously worked for OUSA. Priorities of the UWSA differ from OUSA so he is against. Their financial regard is acceptable, but does it work with the UWSA's goals.

Discussed having more accountability and looking at policies on how UWSA deals with advocacy groups.

Akbar: In favour of the motion. Does not believe that any fees should go up based on inflation.

Orr: The UWSA does not have its own policy on how to deal with membership. There is no bylaw in OUSA on how to deal with membership. If they do not decide to increase fees or pay fees, then they would leave membership with OUSA. Spoke about CFS and it's difficult to leave membership. With OUSA you can give 90 days notice. Because of the renewed membership with OUSA when they have voted in favour of past increases. They have kept good relations with the UWSA to explain this fee increase so much so as to attend tonight's meeting. Inflation is a real world issue not just a fee increase without merit.

Shaun: Against the motion, he doesn't see the need to have the motion since it is based on inflation. It's a natural occurrence then should be considered so.

Hussein (SAL Rob Crawford): Outside perspective, looking at previous expenses 0.04% was spent on lobbying. Why would we allow the increase if they are not lobbying for students?

Akbar: Tabling the motion until Chris brings in policy to address the way the UWSA can address how to work with advocacy groups.
