4.1 Psychology Student Association

Presented by: Joal Craig

- The Psychology Students Association is looking to attend the Canadian Psychological Associations Annual Convention
- In the past students from Windsor have not been able to attend due to distance and cost, however this year the conference is in Toronto

- Is held in June, any student wanting to attend must apply for a CPA membership and then the cost for the Conference is 56.50
- There will be keynote speakers at the conference, attendees are able to choose which seminars they would like to attend, there is also an internship fair where networking is promoted
- Is asking the UWSA for help with travel expenses and specifically the bus costs, bus was quoted at \$2373 and holds up to 47 people

- (A) Craig Would like to cover the bus cost.
- (Q) Bell Said the PSA is funding \$300, is that per student or altogether?
- (A) Craig That is altogether, that is all we can afford at the moment.

4.2 Windsor Charity Ball

- Is a night of elegance, the theme is Venetian Ball
- This is an opportunity for students to come together and give back to the community and a charity in Windsor
- Will be happening on March 27th, 2011 at the St. Clair Centre for the Arts and tickets are \$40 per person
- The projected cost is \$20,000 for around 300 students
- \$1000 will be given to three individual charities
- Sponsor names are going on the ticket and sponsors will be present at the Ball to present a cheque a charity
- We are asking the UWSA for \$2000, however whatever the UWSA see's fit will be fine

- (Q) Bell In past years do you know how much the UWSA has contributed?
- (A) Hegazi No I do not.
- (A) Singh In the past it has been around \$1000 to \$2000's
- (Q) Bell What other places have you asked for donations/support?
- (A) Hegazi I have approached most societies, so far the Computer Society and Science Society are onboard, I am also hoping to hear back from the Social Science Society as well.
- (Q)Bell how much money is going to be re-coupe from ticket sales?
- (A) Hegazi Around 54%.

4.3 Sikh Student Association

Presented by: Jaz Jed

- The Sikh Student Association has roughly 400 plus members
- Each year we provide bus trips to the Sikh Temple free of charge to students
- We are asking for 770.90 to cover the bus costs for this semester
- We work with two other organizations outside of the UWSA, the Sikh Education Research Center and the Windsor Essex Sikh Temple
- Due to the economic down fall we only received \$100 collectively and that has already gone to the bus bill, now we are looking to cover the rest
- Our big event as already happened, last year we took 150 students, this year we took 250

- (Q) Bell who much money was allocated to the Sikh Student Association in first semester?
- (A) Jed \$770.90 last semester

5.0 Discussion

Motion for Mr. Bell to take the chair position.

Motion: Delong Second: Dillon

Singh – The pub is currently in critical condition, finance wise

- Some of the factors are the student meal plan, food and labor costs, and inflation
- The current deficit is around \$75,000
- Mr. coffin and our Sr. Accountant have been working hard to find money to cover this deficit's from our current budget
- \$12,000 has already been allocated to cover some tax bills from January
- At the moment, the pub does need more money in order to stay open, and at the moment we are looking to the board to approve what has already been spent, the \$12,500

Coffin – As of January 1^{st} the pub has lost \$61,000 however some of this has been covered by a loan from the UWSA

- Alcohol sales do not generate enough revenue
- Since Big Dick's has closed the Thursday night pub night's have been doing better and we've had some good Thursday's

Singh – Short-term loans from the UWSA have been \$28, 500 and then an additional \$12, 509 plus another \$10, 000, so out of the \$64,000, \$51,000 has been covered by the UWSA

- Three proposals have been presented to resolve the pub problem
 - One: Keep the pub running as it is, which would cost around \$66.276.91
 - Two: Operate the Thirsty Scholar as a restaurant, with reduced hours, would cost \$47,476.91. For this we have just gotten rid of door staff, which saves us a lot
 - o Three: Shut the pub down completely, will cost \$69, 776.91, this is based on no more sales but a large severance cost

Coffin – We had very high food sales last year, however this year we have taken a large hit due to the changes with the meal plan and food services, so we are only generating about half of what we did last year

- Our Senior Accountant has taken our budget's from up until December and has looked for any disposable income we can find for the pub
- Most money will be coming from the contingency fund from central administration
- As of right now we are running a deficit and will be leaving the future with a problem, however we will not be going bankrupt this year
- Overall, we will most likely break even for the year, but we are being dragged down by the pub
- And must ask ourselves, will the pub be able to pay back the loan, ultimately no, they will not

Ouestions

- (Q) DeJong What was the Pub's loss for last year?
- (A) Coffin It was around \$6200
- (Q) Mukit Will food services change their decision?
- (A) DeJong Most likely no, we are in the process of trying to push administration to change their decision with food services, but it does not look like they will
- (Q) DeJong what are your suggestions for the pub next year?
- (A) Coffin we need to choose one of the three proposals. If we can find a business model to break even next year then we can make this work. What the board needs to think about at the moment is can the UWSA afford to forward money to the pub or is this board going to say no to forwarding money and will you be recommending to the future board to do the same. If this is the case, then the pub needs to find money from somewhere else. Another choice could be allowing another company to rent out the pub and pay the UWSA rent, though the University of Windsor will most likely be very against this. The last option could always be partnering with food services and trying to run the pub together, however this is unlikely.

- (Q) DeJong Why hasn't this come to board earlier, like why hasn't it taken until the pub was in \$65,000 debt to bring this issue up?
- (A) Coffin The problem did not show itself until last month, so I think the real question was why didn't it come last month.
- (S) Why didn't the pub manager not identify and bring this problem forward?
- (A) It is not just the pub manager that is to blame here, the General Manager and VPFO also receive daily sales invoices from the pub, so it has been watched from day to day. The pub manger takes care of staffing, which seems to be our largest problem and specifically door staff.

Singh – It seems like door staff and having excessive door staff is a large problem. If we continue to operate with as we are at the moment, with the reduced hours and are more aggressive with our sales there is a chance to break even or at least do a bit better.

Coffin – We will not be running the pub during the summer and this will resolve \$10,000's. As of right now, we need to do something about this problem because eventually this money that the pub is losing is going into a debt category for the UWSA and will eventually turn into the deficit for the UWSA.

PSA Funding Request

We continue to have funding requests each week and they are not going to stop.
